PLAYER’S AGREEMENT

TO ENTER AVC OFFICIAL BEACH VOLLEYBALL EVENTS



BETWEEN

Ms./Mrs./Mr.(herein after the “**PLAYER**”)

and

Asian Volleyball Confederation, P.O. Box 6130, Beijing, 100763, China (hereinafter the “**AVC**”)

THEREAS

- The AVC is willing to accept the enrolment of THE PLAYER and the later is requesting the right to be admitted into any and all Beach Volleyball tournaments organised by an affiliated Association or by the AVC itself in any part of Asia (hereinafter “**Official Events**”) during the period of January 1st to December 31st, 200...
- The AVC is willing to obtaining in exchange for itself and for its licensees the Right to use throughout Asia THE PLAYER’s identification in connection with photos, films, videos computer games hereinafter designed as “**Licensed Products**” in connection or related exclusively to one tournament or to ensemble of **Official Events** to which the PLAYER agrees.
- The player is willing in exchange to be granted the Right to participate in any and all Beach Volleyball **Official Events** and have access to the Event in herent rights.
- The PLAYER, the AVC and its Licensees will abide by this agreement and by the **Player’s Sponsorship Commitment** as approved by the AVC Beach Volleyball Council every year.

NOW THEREFORE THE PARTIES AGREE TO THE FOLLOWING:

1. “**THE PLAYER Identification**” shall mean the name, the image, likeness, visual representation of THE PALYER, and any combination of any of the foregoing.
2. The PLAYER herby grants to AVC and to its Licensees the right and license to use THE PLAYER Identification, but it is expressly understood and agree herein that the Licensee will not use THE PLAYER Identification for advertisement or promotion (especially on the packaging of its products) in such a way that THE PLAYER should not appear alone as endorsing the product. Such appearance will have to be negotiated by a separate contract with the player.
3. All Player’s and AVC’s sponsorship rights and obligations are mutually granted to each other as mentioned herein and in the Player’s Sponsorship Commitment and they remain the property of the AVC and/or THE PLAYER, accordingly. The AVC and its Licensees understand that THE PLAYER has reserved the right to authorise others to use THE PLAYER’s Identification during the contract period.
4. “**Control Period**” for competition and Player’s Sponsorship commitment shall mean one year but licensees may extend it to two (2) years with the prior agreement of the Player.
5. “**Territory**” shall mean the continent of Asia.
6. **Materials.** THE PLAYER will give the AVC, whenever possible, an access free of charge to materials concerning THE PLAYER such as pictures, movies and the like.
